Board of Juvenile Justice Thursday, August 27, 2020 Decatur, GA Board Meeting Minutes (Audio Conference)

Opening Remarks

On Thursday, August 27, 2020, Chair Taylor called the meeting of the Board of Juvenile Justice to order at 10:00 AM. The meeting was held as an audio conference.

Chair Taylor asked for a motion to approve the agenda. The motion was made by Board member Yarbrough, seconded by Vice-Chair Bolton, and approved unanimously.

Chair Taylor called for a motion to approve the minutes of the August 27, 2020 Board meeting. Board member Coleman moved that the August 27, 2020 minutes be approved. The motion was seconded by Board member Kaiser and approved unanimously.

Commissioner's Report

Commissioner Tyrone Oliver provided the Commissioner's Report to the Board. The latest COVID-19 numbers (staff and youth) were provided. Staff was commended for efforts to minimize COVID-19 spread. Commissioner Oliver also mentioned the new JCO uniform rollout to go along with the new mission statement and culture change. He Spoke about the "F.R.E.S.H. Start" re-entry job program in partnership with the Pinky Cole Foundation (the "Slutty Vegan" restaurants).

Commissioner Oliver mentioned the efforts to reduce paper consumption for the Board materials.

He also mentioned the teacher vacancies. Chair Taylor asked about the special education enrollment rate. Superintendent Oliver commended education, medical, and health services staff for minimizing COVID-19 spread. Dr. Rufus Johnson talked about the upcoming re-accreditation process for the Georgia Preparatory Academy. Deputy Superintendent Shelfer discussed the federal grant review and the joint project with the Office of Behavioral Health Services (OBHS) and Secure Facilities called "T.A.R.G.E.T." Chair Taylor commended Superintendent Oliver and staff.
