The data in the table above represents the number of DJJ employees or youth who have a confirmed positive test for COVID-19 as of 1 p.m. on July 17, 2020. Approximately 62 Secure Facilities employees, 20 Community Service Division employees and eight Central Office employees have tested positive for COVID-19. Thirty-two of 90 employees have received medical clearance. A total of 64 youth have tested positive for the virus; 28 have received medical clearance following 14-days of isolation.
