The data in the table above represents the number of DJJ employees or youth who have a confirmed positive test for COVID-19 as of 3:30 p.m. on July 27, 2020. Approximately 74 Secure Facilities employees, 20 Community Service Division employees and nine Central Office employees have tested positive for COVID-19. Thirty-seven of 103 employees have received medical clearance. A total of 66 youth have tested positive for the virus; 34 have received medical clearance following 14-days of isolation.
