Board of Juvenile Justice Thursday, February 27, 2020 Decatur, GA

Opening Remarks

Chair Taylor called to order the meeting of the Board of Juvenile Justice at 10:02 am. The meeting was held at the DJJ Central Office, Decatur, GA.

Commissioner's Report:

Director of Investigations Matt Wolfe presented a commendation to Investigator Caitlyn Weber.

The Faithful Service Awards were presented by the Office of Human Resources. There were three employees that received awards.

Commissioner Tyrone Oliver talked about Board Member Coleman's Senate Resolution recognizing his contributions to the State and juvenile justice.

Real Estate and Property Insurance Manager Teri Stripling presented two board resolutions for adoption: 1) lease renewal of a portion of Augusta YDC with Masters City Little League, Inc. The SAVRY presentation slides were included in the board member materials to be presented at a future meeting (Addendum C). Commissioner Oliver also provided a legislative update.
