# Policy and Procedures Regarding Transfer of DJJ Youth to DCS

#### **Board of Education**

During the DJJ Board of Education meeting, the following topics were discussed:

- Associate Superintendent Armistad presented a former DJJ youth, T. W. with his high school diploma. T. W. was previously released from DJJ to DOC. Upon his release from parole, he was one credit short of receiving his diploma. Special recognition was given to two education staff members for going above and beyond to ensure that T. W. got the support that he needed to complete the requirements to receive his diploma.
- Superintendent Niles presented the Board with the Certificate of Accreditation and congratulatory letter from AdvancEd. The accreditation is valid until June 30, 2021. For additional information, please see Addendum E.
- Superintendent Niles recognized Associate Superintendent Armistad for 30 plus years of service to DJJ and the State of Georgia.
- Associate Superintendent announced her retirement, effective October 31, 2016.
