Opening Remarks

Chair Elaine Snow called to order the meeting of the Board of Juvenile Justice at 10:02 am. The meeting was held at DJJ Central Office Decatur, GA.

Chair Snow asked for a motion to approve the current agenda. A motion was made and seconded. The motion carried unanimously.

Chair Snow asked for a motion to approve the minutes of the May 25, 2017 Board Meeting. A motion was made by Board Member Yarbrough and seconded by Board Member Bolton. The motion carried unanimously.

Commissioner's Report

The Commissioner Report was previously submitted to the Board via email and it was included in the Board materials.

The following topics were discussed:

Commissioner requested a moment of silence for the GA Department of Corrections Officers killed in the line of duty in Putnam County.

The Commissioner mentioned reorganization of the Department's leadership for Secure Facilities.

Deputy HR Director Harold Cooper awarded Employee Faithful Service Awards to DJJ employees.

Board Member Yarbrough commended the Commissioner and staff regarding the Commissioner's Youth Council. He was also impressed with the youths.

Commissioner mentioned Assistant Commissioner/Chief of Staff Joe Vignati's testimony before Congress in Washington, DC, regarding juvenile justice reforms.

The Commissioner stated that a legislative summary will be distributed to the Board via email as well as the 1998 DOJ MOA and outline. He also mentioned that the AU contract going into effect on July 1, 2017.

DJJ will host a Family Day on July 8, 2017, as part of its family engagement efforts. The focus will be on education. The Commissioner mentioned that one of the issues affecting family involvement is transportation difficulties.

Board Member Yarbrough asked about destruction of DJJ property by youth. Board Member Colbert mentioned her visits to other states' juvenile justice systems and the different models. The Commissioner discussed culture changes and other trauma treatment based training. Board Member Neighbors agreed that trauma-informed services are important. Board Member Edwards discussed the prior contract home program. Assistant Deputy Commissioner of Community Services Victor Roberts provided a historical background regarding the program. Commissioner mentioned the different opportunities that are available now. Judge Teske discussed looking at the data. Board Member Neighbors would like to see what other states are doing. Board Member Ambrose expressed some concerns regarding the contract home program.

Board Member Bolton wanted a Wilkes facility update. The facility is on schedule.

Chair Snow asked for a motion to adjourn from the regular DJJ Board Meeting and reconvene as the DJJ School Board. A motion was made by Board Member Taylor and seconded by Board Member Coleman. The motion carried unanimously.

Curriculum Director Keishia Douglas presented on the summer education program **(Addendum A)**. Associate Superintendent Jean Lee gave an update of the Education Summit as well as the status of the STEM teacher position and reaching out to the technical schools. Board Member Yarbrough would like the Teacher of the Year recognized at the next Board meeting.

Chair Snow asked for a motion to adjourn from the DJJ School Board and reconvene as the regular DJJ Board. A motion was made by Board member Coleman and seconded by Board member Ambrose. The motion carried unanimously.
