Opening Remarks

Chair Elaine Snow called to order the meeting of the Board of Juvenile Justice. The meeting was held at the DJJ Headquarters, 3408 Covington Highway, Decatur, GA 30032.

Chair Snow asked for a motion to approve the current agenda. A motion was made by Board Member Holt and seconded by Board Member Coleman. The motion carried unanimously.

Chair Snow asked for a motion to approve the minutes of the April 20, 2016 Board Meeting. A motion was made by Board Member Coleman and seconded by Board Member Colbert. The motion carried unanimously.

Commissioner's Report

Commissioner Niles discussed the graduation ceremony from May 20, 2016, and he recognized the Governor and First Lady Deal for their inspiring commencement speeches to the Georgia

Preparatory Academy Graduates. The Commissioner also talked about a youth field trip to the Sea Turtle Conservation as an incentive for PBIS.

Budget Update

Chief Financial Officer Sonja Allen-Smith presented on budget updates. Board members were interested in the additional funds for juvenile justice reform programming services. Board Rule Changes and MOU

General Counsel Cindy Wang presented on the proposed amendments to Board Rules in Chapter 97-1, "Rules of General Applicability," and Chapter 97-2, "Administrative Revocations of Juvenile Community Placement," which revises the definitions and the Board's Authority to become consistent with current law and practice. She also presented on a new proposed Board Rule Chapter 97-5, relating to the transfer of community supervision of certain youth in the Department's custody to the Department of Community Supervision, to comply with the passage of SB 367 (2016 Georgia Laws). General Counsel Wang presented on the Memorandum of Understanding (MOU) between the Department of Community Services (DCS) and Department of Juvenile Justice (DJJ) would delay implementation of the transfer of community supervision services for certain youth until after September 1, 2016. For additional details on this topic, please see **Addendum C**.

Chair Snow asked for a motion to initially adopt the proposed Board Rule Changes. approve Board Member Coleman made a motion to initially adopt the proposed Board Rules Changes and Board Member Edwards seconded the motion. The motion carried unanimously.

Chair Snow asked for a motion to approve the MOU between DJJ and DCS. Board Member Colbert made a motion to approve the MOU and Board Member Edwards seconded the motion. The motion carried unanimously.

Chair Snow asked for a motion to adjourn from the regular DJJ Board and reconvene as the DJJ School Board. A motion was made by Board Member Holt and seconded by Secretary Kennedy. The motion carried unanimously.

Board of Education

Associate Superintendent Armistad discussed the following topics during the School Board Meeting:

• The total of graduates for each GPA school for the last three years. For additional details, please see **Addendum D**. The total number of diplomas awarded this school year was 90. Sixty-one students were able to participate in the graduation.

- The end of the year audit by the Georgia Department of Education, which showed only one minor finding, which related to inventory.
- The next graduation for the Georgia Preparatory Academy will be held on December 15, 2016 at Tift College, Forsyth, Georgia.
