## Board Meeting Summary October 22, 2020 (Audio/Teams Conference)

Motions and Other Business:

- 1. Chair Taylor called the meeting of the Board of Juvenile Justice to order on Thursday, October 22, 2020, at 10:02 AM.
- 2. Board Member Blackmon moved for the approval of the agenda. It was seconded and approved unanimously.
- 3. Board member Holt moved for the approval of the September 24, 2020 minutes. It was seconded and approved unanimously.
- 4. Commissioner Tyrone Oliver provided the Commissioner's Report. He welcomed newest board member, Chief Gary Yandura, and provided an update on DJJ's budget legislative meetings. Commissioner Oliver also gave a COVID-19 update (staff and youth). He commended facility and health services staff for working hard to minimize COVID-19 impact.
- 5. Director of Professional Development and Standards Latera Davis presented on the proposal to change the BJCOT Training program and the partnership with the Home Depot regarding the leadership training program. She also discussed the peer support program along with upcoming wellness and health programs for DJJ's staff members. Director Davis also spoke about DJJ's partnerships to raise money for charity. Commissioner Oliver mentioned how the peer support program will assist with stress management.
