Motions and Other Business:

- 1. Chair Sandra Taylor called the meeting of the Board of Juvenile Justice to order on Thursday, September 23, 2021, at 10:10 AM.
- 2. Board Member Joyette Holmes moved for the approval of the agenda. It was seconded and approved unanimously.
- 3. Board Member Gary Yandura moved for the approval of the August 26, 2021 minutes. It was seconded and approved unanimously.
- 4. Commissioner Tyrone Oliver sent his condolences to the family and Wilkes RYDC family of Sgt. Lisa Denise Huff regarding her passing on September 14, 2021. The Commissioner updated the Board on the release of the FY 2021-22 Annual Report and provided a COVID-19 update.
