## Appointment of L. Gale Bucker, Commissioner

Chairman Dr. Edwin Risler Board of Juvenile Justice Chairman Risler said the Special Called Board Meeting is due to Governor Nathan Deal designating L. Gale Buckner to be the new commissioner of the Department of Juvenile Justice.

Chairman Risler said under Georgia law it is the responsibility and duty of the Board to approve the appointment of the Commissioner as recommended by the Governor. Chairman Risler thanked Amy Howell (in absentia) for the leadership she showed over the past nine months and wished her well in her future endeavors.

Chairman Risler asked Bart Gobeil, Governor Deal's chief of staff, to say a few words to the Board. Mr. Gobeil thanked the Board on behalf of Governor Deal. He said Governor Deal is very excited about Buckner's tenure and has confidence in her and looks forward to the Board's permanent approval of her nomination.

Chairman Risler asked for a motion that Buckner be appointed as the new commissioner of the Department of Juvenile Justice, replacing Amy Howell, to be effective immediately.

The motion was made by Board Member Snow to appoint Buckner the Commissioner of the Department of Juvenile Justice. Board Member Menefee seconded the motion.

Chairman Dr. Risler asked if there was any discussion. Hearing none, he asked Board Secretary Taylor to have a roll call vote.

The Board voted unanimously in support of the motion.

Chairman Dr. Ed. Risler stated the vote carries and Buckner is the Department of Juvenile Justice's new Commissioner. The Board congratulated Commissioner Buckner.

Chairman Risler said Commissioner Buckner will be sworn in at the Capitol on Monday November 14, 2011 at 3:00 p.m. He encouraged the Board to attend and stated Emily Gest will send out information to the Board about the ceremony.

Chairman Risler asked for a motion to adjourn the Special Called Meeting of the Board of Juvenile Justice. It was motioned by Board Member Simpson and seconded by Board Member Taylor for the meeting to be adjourned.
