Department of Juvenile Justice Recruiting in AUGUST DJJ Recruitment Fair Slated for Atlanta Technical College

(ATLANTA - GA) The Atlanta Technical College campus on Metropolitan Parkway is highlighted as the site for DJJ recruiting activities on this month's recruitment calendar.

During the upcoming job fair on August 26th, 2015, Georgia's Juvenile Justice Commissioner Avery D. Niles is sending teams of recruiters to seek qualified candidates to fill essential juvenile correctional officer (JCO) positions. ***DJJ recruiters are authorized to conduct on-the-spot interviews for qualified JCO1 candidates*** during a full cycle employment process that day.

Commissioner Niles says DJJ needs mature adults and professionally motivated officers who can help Georgia's juvenile offenders make successful reentry from the juvenile justice system back to society as productive citizens.

Representatives from each DJJ Division will be on hand to speak to attendees about a full range of meaningful employment opportunities at the Department of Juvenile Justice, including roles and requirements for teachers, nurses, behavioral health specialists, administrative professionals, food service workers and probation officers.

The Commissioner says DJJ is also on the lookout for Georgia veterans with public service know-how and chain of command experience. ***"DJJ is a great place to make your work count,"*** Commissioner Niles said.

All job seekers can click on www.djjcareers.org for more information about career opportunities in juvenile corrections. In order to progress smoothly through the Juvenile Correctional Officer interview process, candidates should bring the following:

- Copy - Birth Certificate
- Copy - High School Diploma or GED
- Copy - Valid Driver License - State issued ID
- Copy - Social Security Card
- Copy - Compass Test Scores, SAT Scores or ACT Scores
- Copy - P.O.S.T. Profile for Certified Officers

**** If applicants have a 4-year degree from an accredited college they are exempt from taking the Compass test or providing proof of acceptable ACT or SAT scores.**
